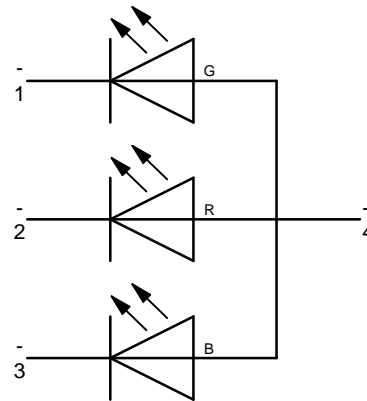
RBG: Triangular Chip Layout

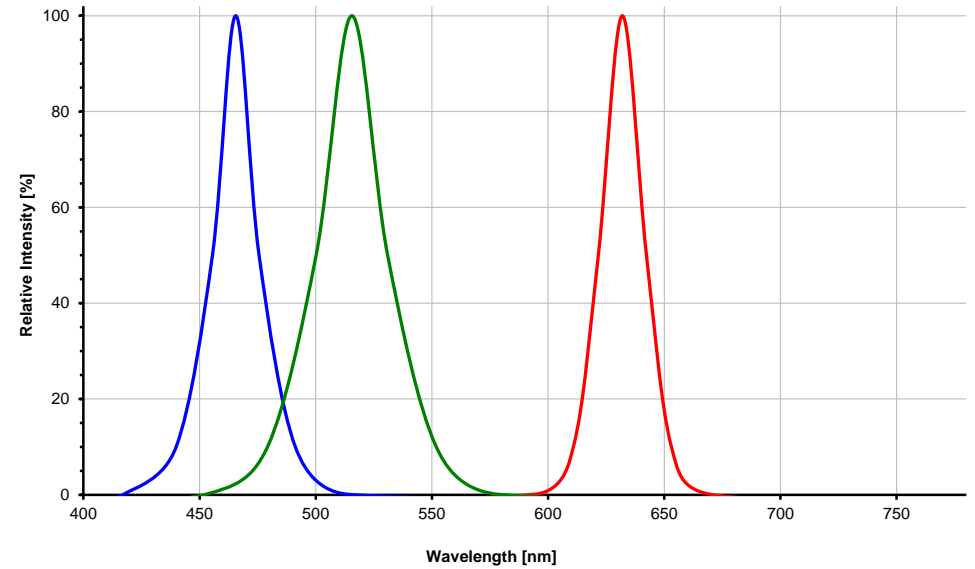

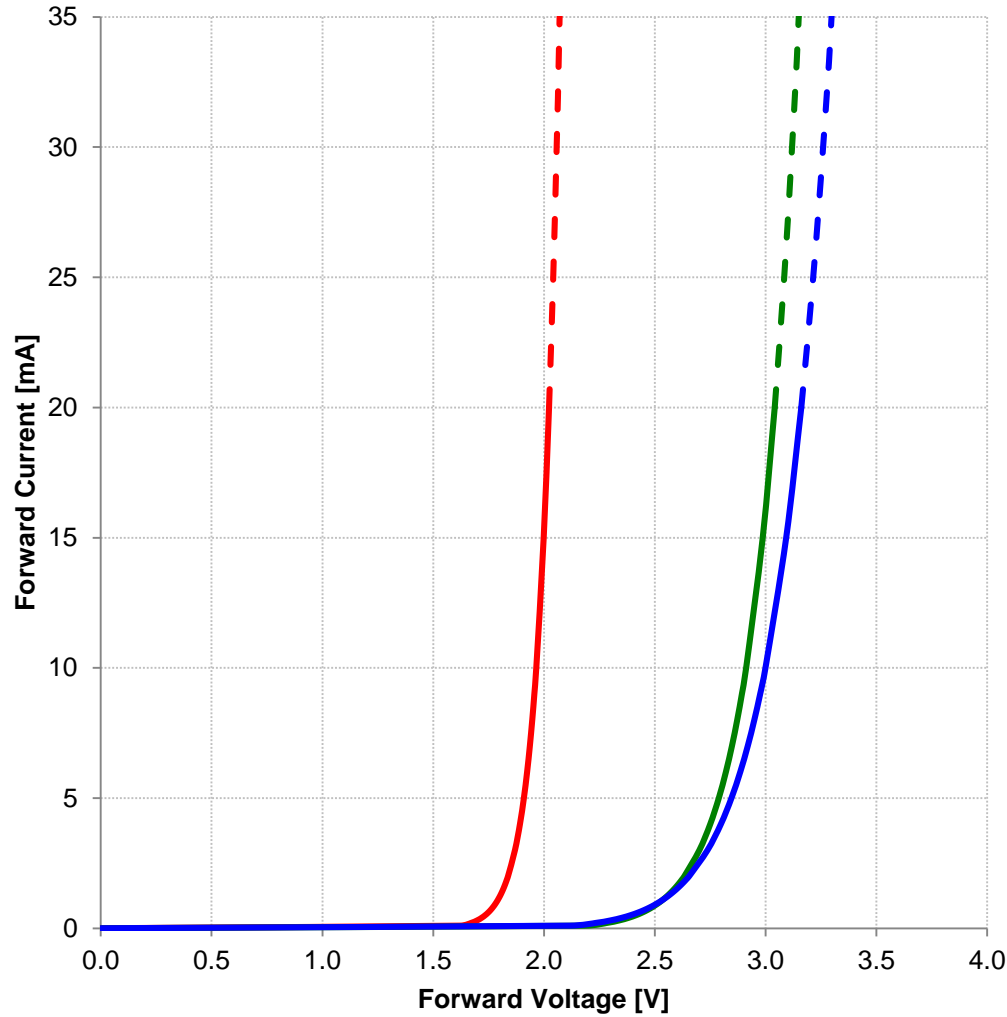

Luminous Intensity vs. Forward Current:

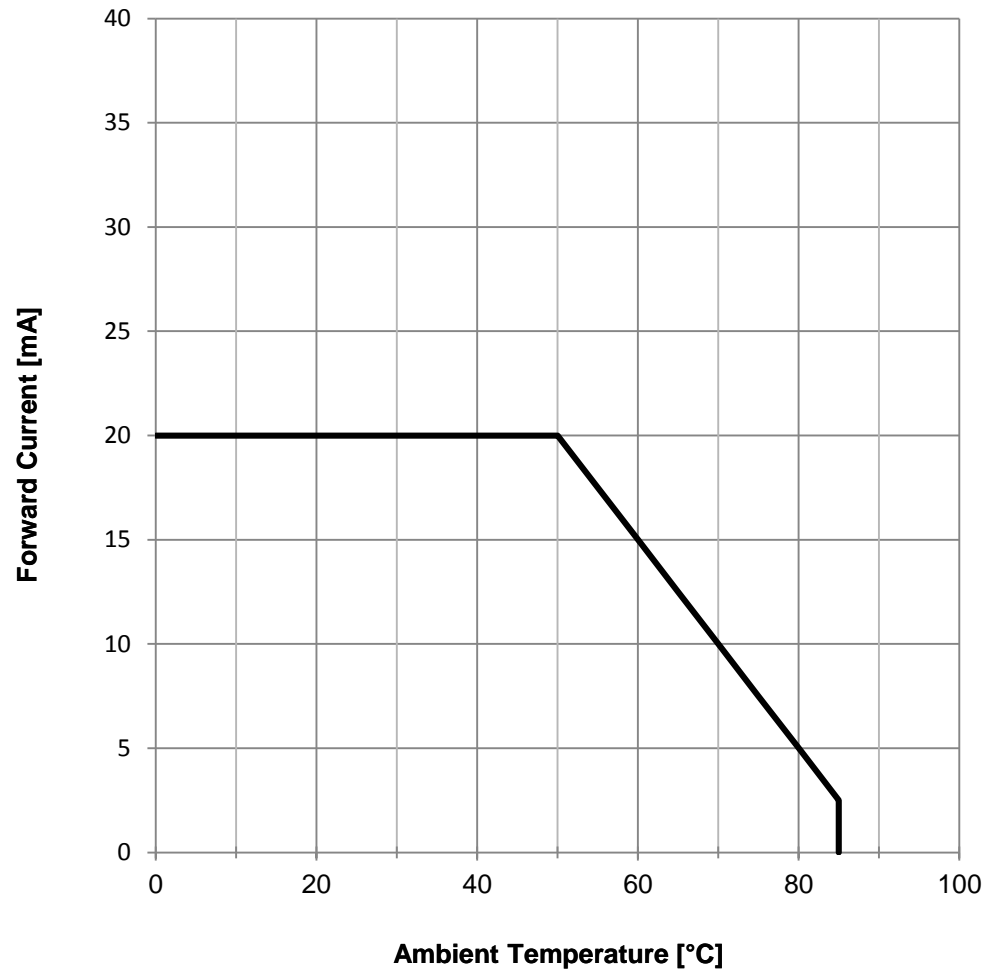



Product specific:


