1. General description

Ultra low clamping bidirectional ElectroStatic Discharge (ESD) protection diode designed to protect one signal line from the damage caused by ESD and other transients. The device is housed in a leadless ultra small DSN0603-2 (SOD962) Surface-Mounted Device (SMD) package.

2. Features and benefits

- Bidirectional ESD protection of one line
- Ultra small leadless package with a height of 0.3 mm
- IEC 61000-4-5 (surge): $I_{PP} = 14$ A peak pulse (average measured)
- Very low clamping voltage: $V_{CL} = 7.1$ V typical at 16 A for a TLP pulse
- Ultra low leakage current: $I_{RM} = 1$ nA (average measured)
- ESD protection up to 22 kV

ESD surge protection for:

- Very sensitive interface lines
- Generic interface lines

in portable electronics communication, consumer and computing devices

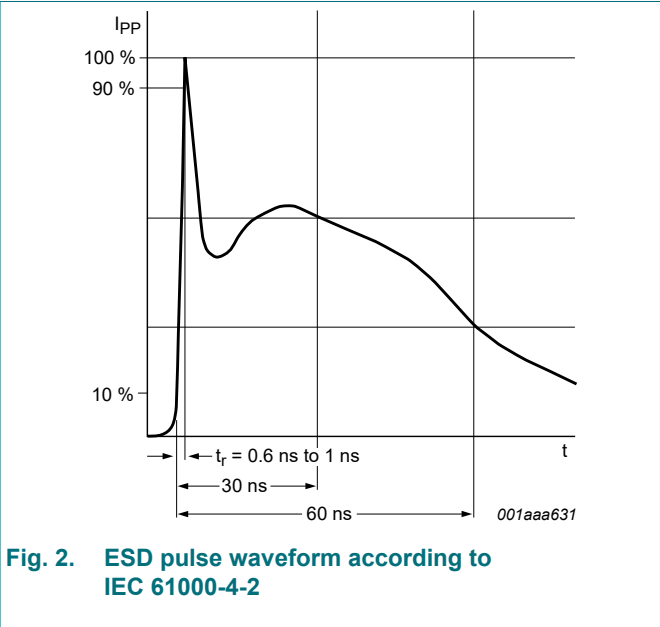

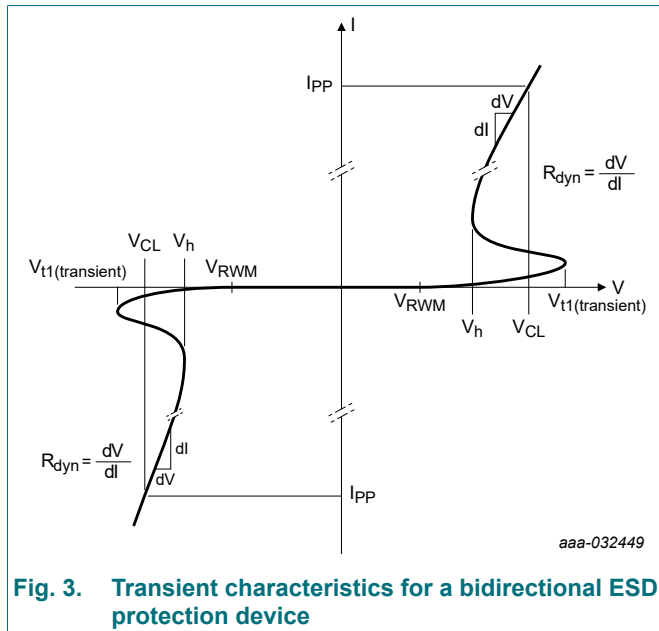


Fig. 3. Transient characteristics for a bidirectional ESD protection device

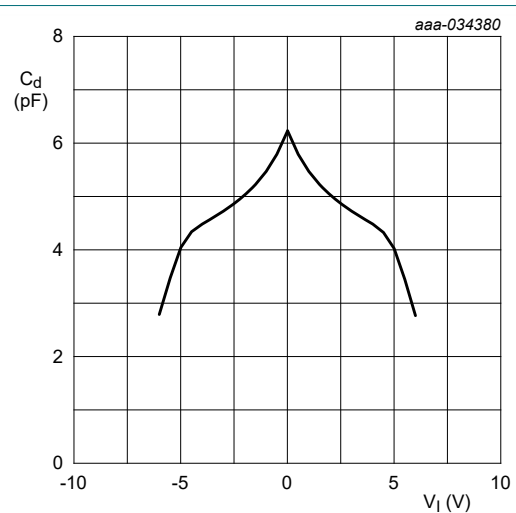
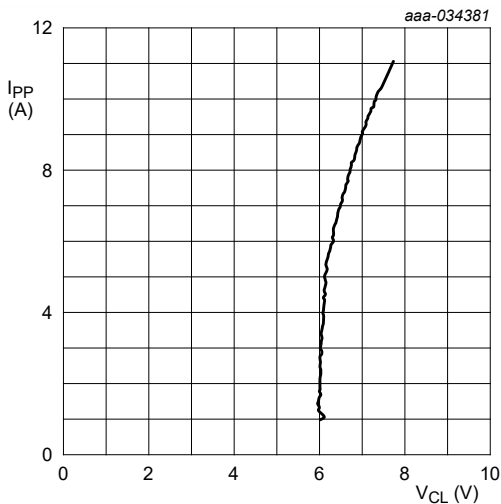
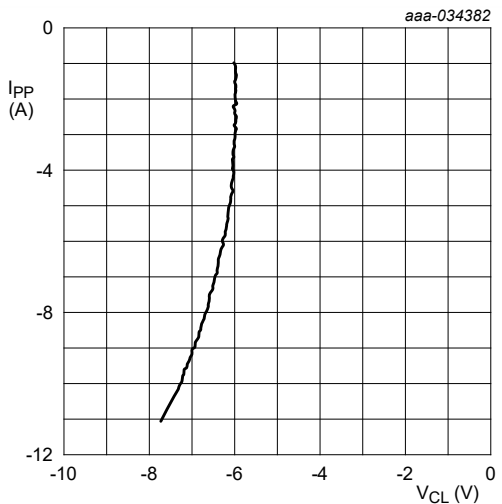


Fig. 4. Diode capacitance as a function of input voltage; typical values



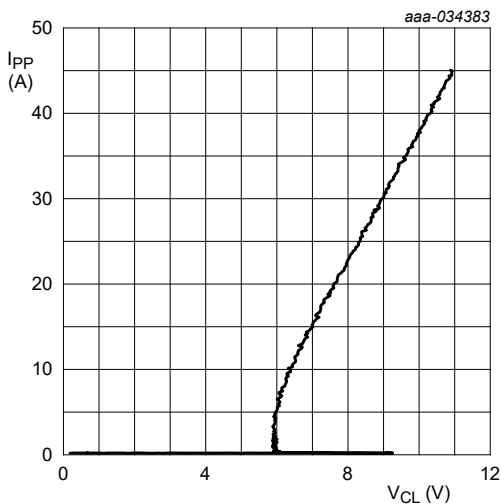

Fig. 5. Dynamic resistance with positive clamping; typical values



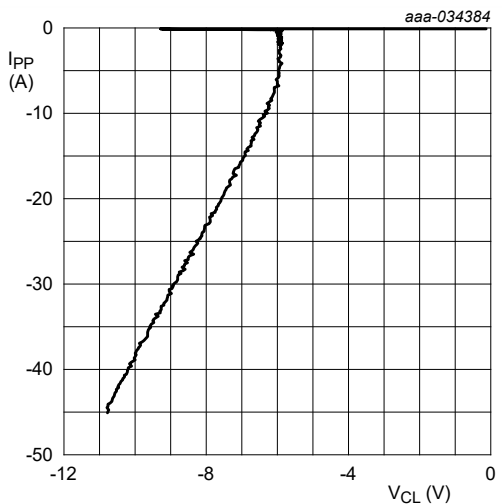
IEC 61000-4-5; $t_p = 8/20 \mu s$; negative pulse

10. Application information

The device is designed for the protection of one bidirectional data line from surge pulses and ESD damage. The device is suitable on lines where the signal polarities are both positive and negative with respect to ground.

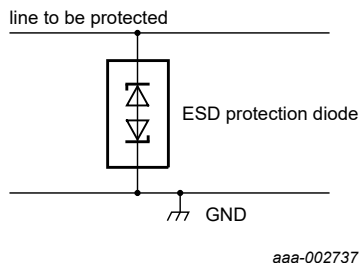


Fig. 9. Application diagram

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

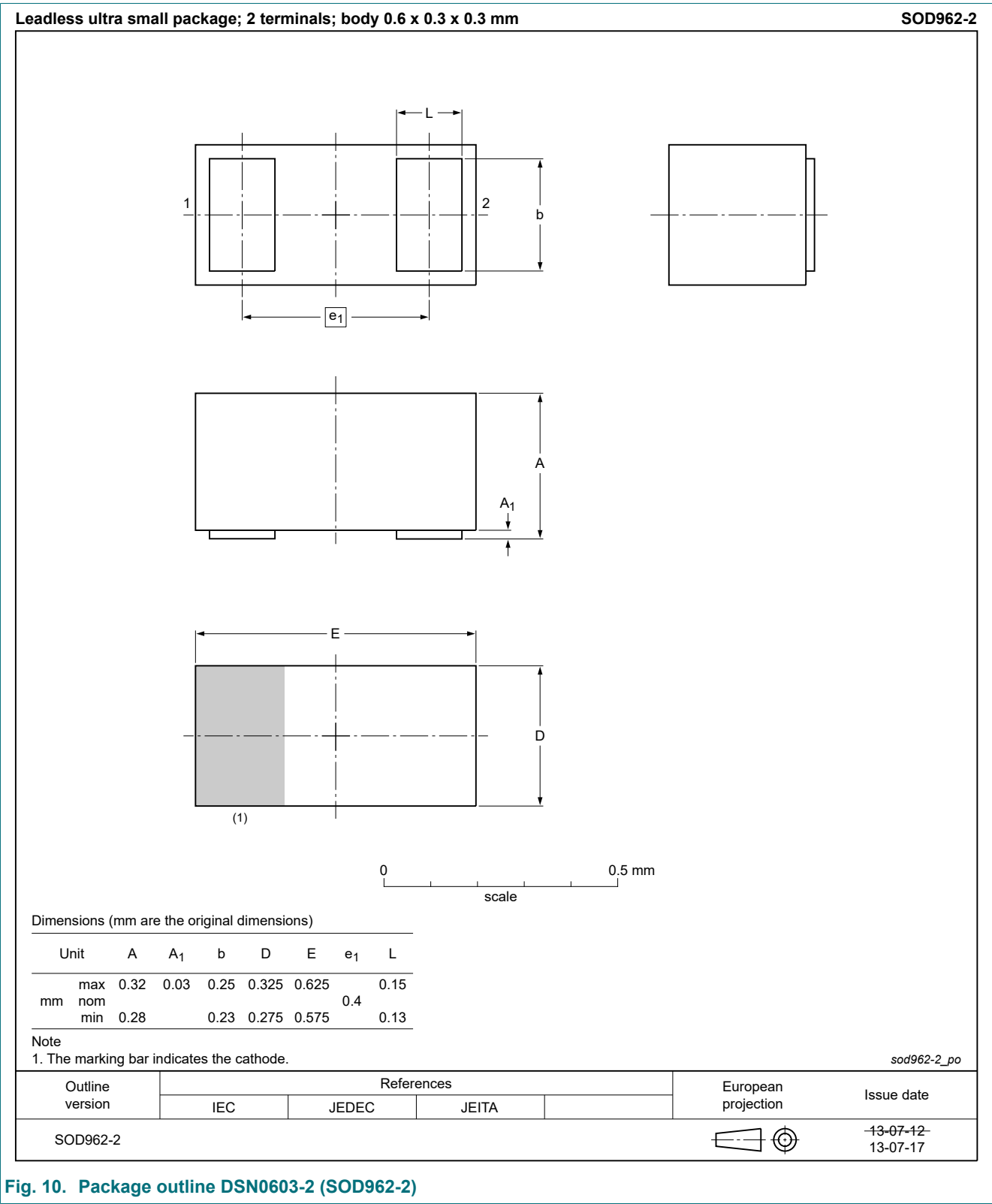


Fig. 10. Package outline DSN0603-2 (SOD962-2)

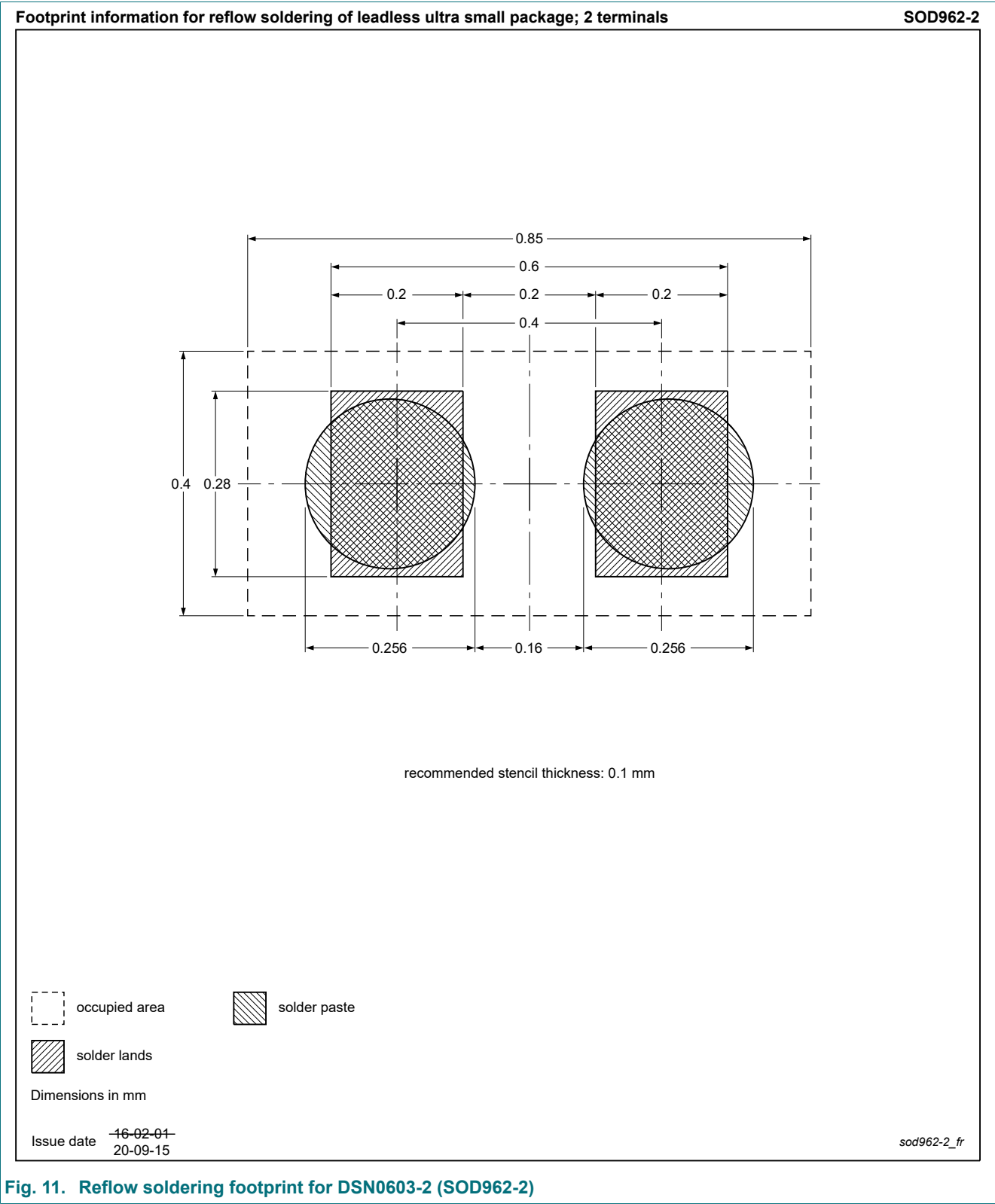


Fig. 11. Reflow soldering footprint for DSN0603-2 (SOD962-2)
