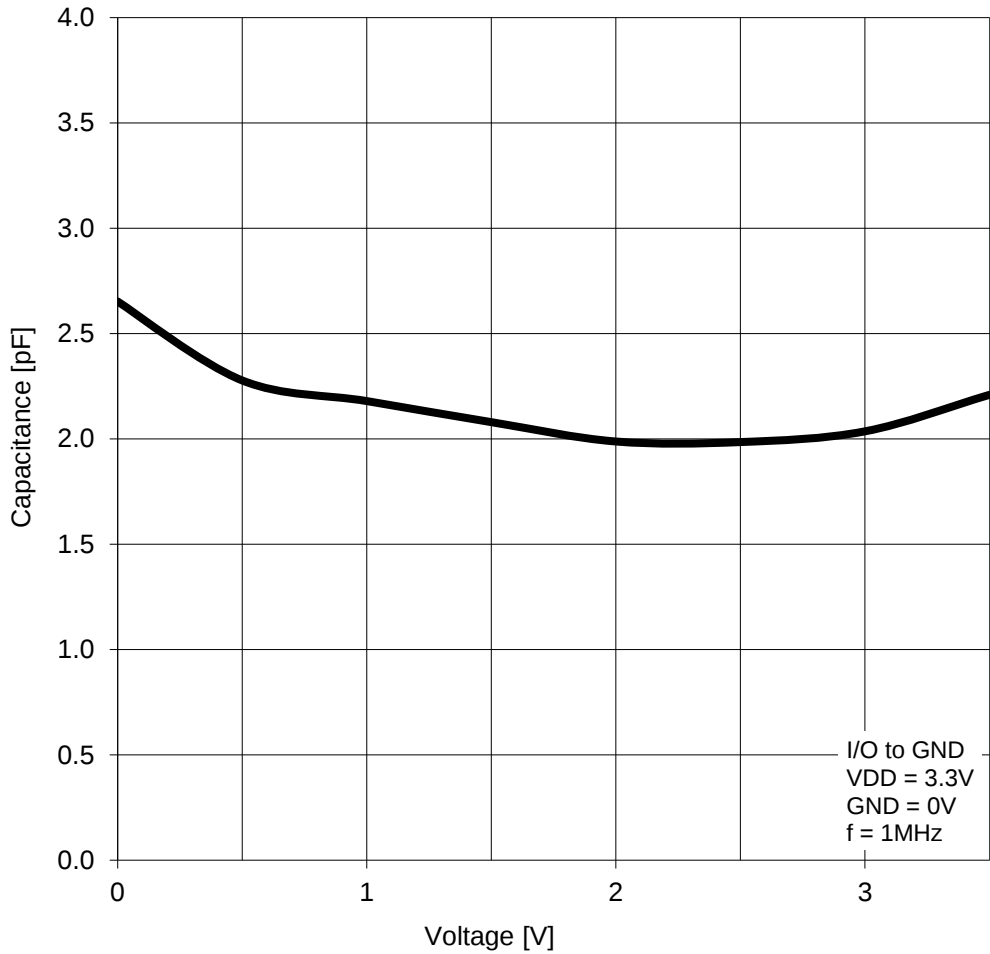
Transmission Line Pulsing (TLP) Measurement:



Clamping Voltage vs. Peak Pulse Current:



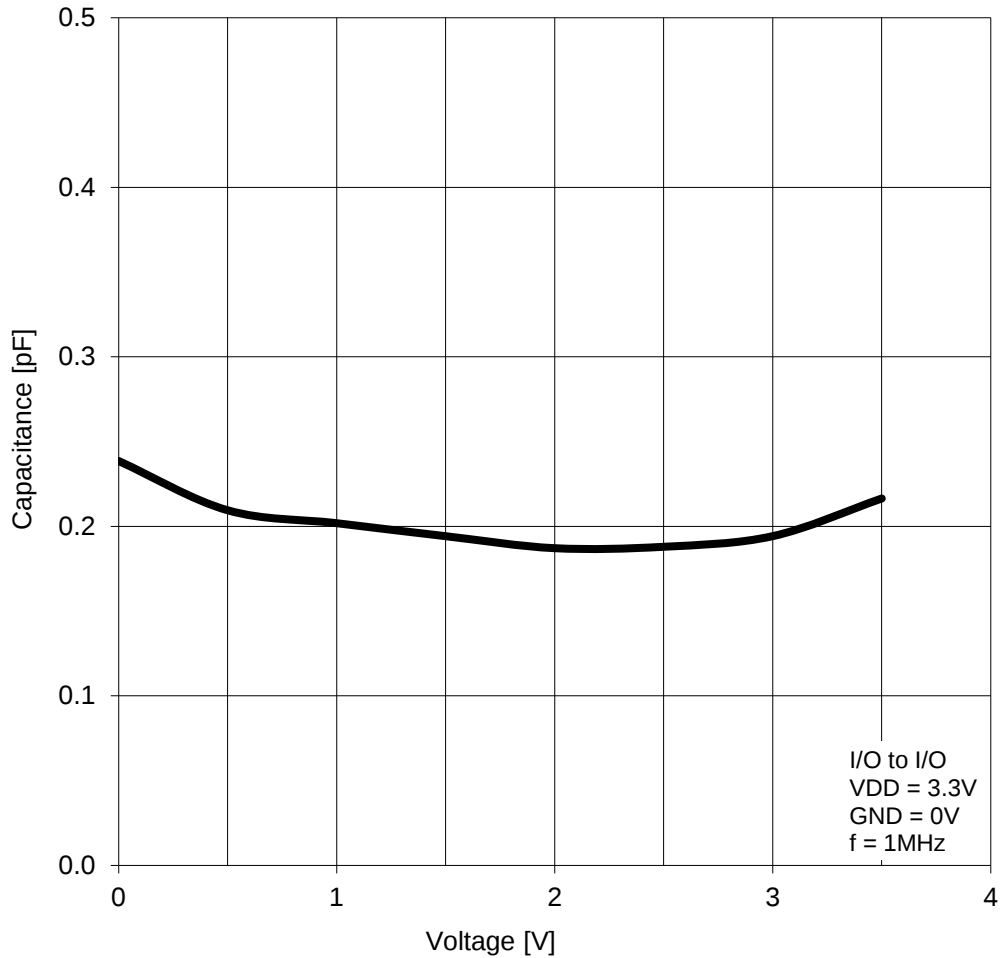

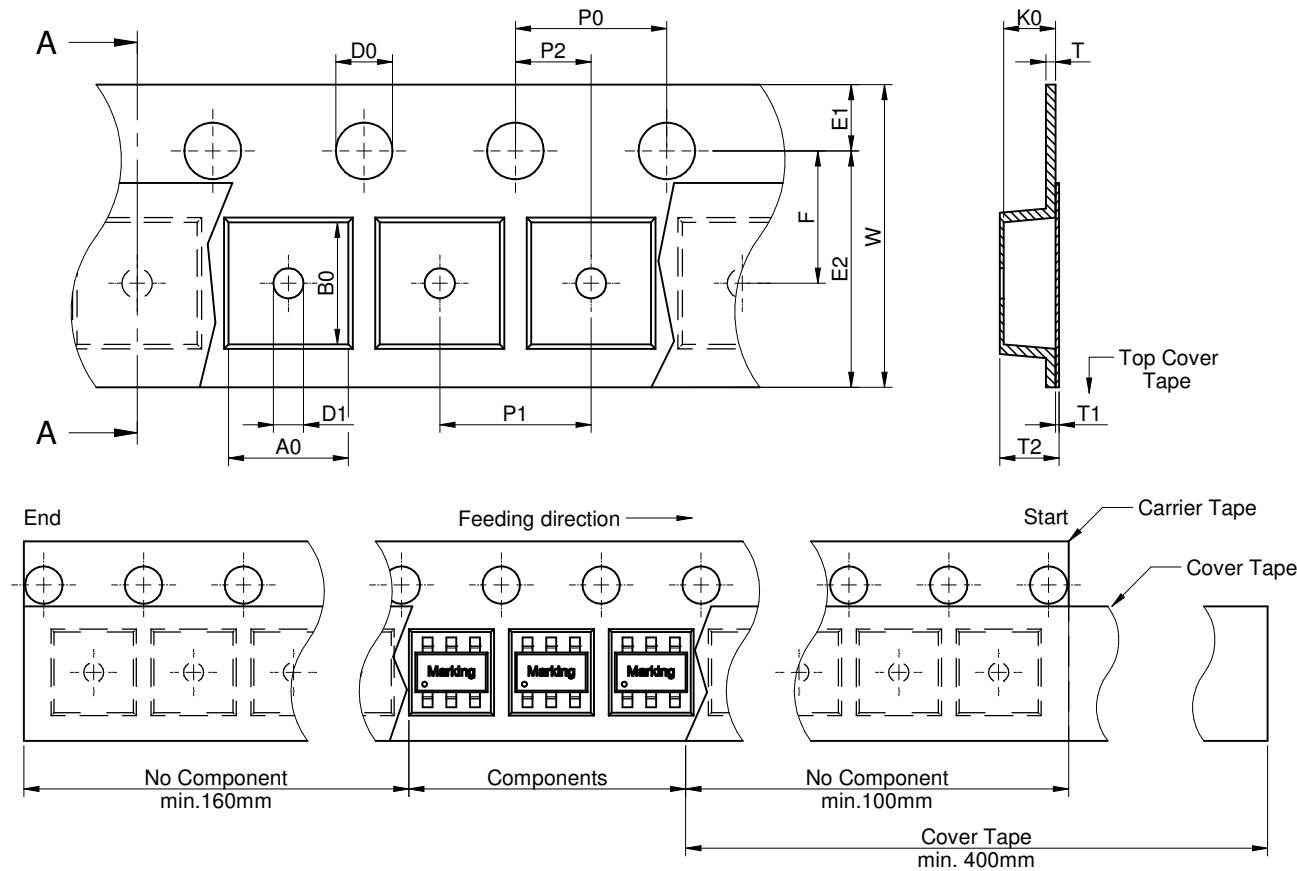

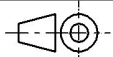
